**SPLASHDOWN WATERPARK SEASON PASS
TERMS AND CONDITIONS**

1. **No outside food or beverage is permitted in the park.** Baby food and water is allowed. SplashDown team members are not permitted to store food.
2. SplashDown Waterpark reserves the right to close the park for private rentals. Please visit our website for these dates.
3. No alcoholic beverages are permitted in the park or in pavilions outside of the park. Alcohol consumption is only allowed with catering services provided by SplashDown Waterpark.
4. Swimsuits are required to enter any aquatic area. Gym pants, cut-offs, and street clothes are not considered proper swimming attire. Non-toilet trained children must wear swim diaper and snug fitting plastic pants.
5. Personal floatation devices, toys, masks, fins, and snorkels are not permitted.
6. Only Coast Guard approved lifejackets are permitted. SplashDown provides these lifejackets in many sizes to all guests free of charge.
7. Children under 12 years of age must be accompanied by an adult at all times. Non-swimmers and small children must have an adult within arms reach at all times.
8. Please abide by all posted signs, lifeguard/staff instructions, and attraction height restrictions.
9. Paging of guests is not permitted. Parents should pre-arrange a pickup time and location for children.
10. No one will be admitted into the park without a ticket or season pass.
11. No pets will be permitted into the park except service animals.
12. Please shower before entering the water.
13. SplashDown is a smoke-free facility except in designated smoking areas. Please see the park map or ask a team member for these locations.
14. Food and drink is not permitted in the water, cue lines, or on attractions.
15. Guests with open sores or evidence of a communicable disease will be denied entry into water areas.
16. Foul language, line jumping, and unsafe behavior will not be tolerated. Illegal activity or damage to park property will result in immediate revocation of pass without a refund and will be turned over to the proper authorities.
17. Season pass purchase does not guarantee admission. If capacity is reached, guests are admitted as others leave for the day.
18. This agreement may be cancelled within 72 hrs of purchase. After 72 hours refunds will only be granted for job transfer, move out of Prince William County, or medical disability with a letter from doctor's office. A \$25 fee will be charged for all cancellations.
19. A season pass is a revocable license. Failure to abide by park rules may result in pass revocation. No refund will be issued in this instance.
20. Lost or stolen season passes are subject to a \$10 replacement fee. Card is required for admission. Passes are non-transferable.
21. The season pass plan is considered a discounted admission. Therefore, it cannot be combined with any other discount, coupon, or promotion.
22. SplashDown Waterpark is not responsible for lost or stolen articles. Lockers are available for rent from Guest Services.
